# **Financial overview**

- Sales increased by 1.0% Y/Y to €3,603m with volume +6.1%, price -4.2%, FX -0.9%
- EBITDA increased to €287m (Q3'23: €277m) driven by volume effect of €+92m, pricing delta of €-126m, FX of €-2m and others of €+46m (incl. €-6m from STRONG restructuring cost)
- EBIT of €76m (Q3'23: €71m) with D&A of €211m (Q3'23: €206m)
- Financial result of €-24m (Q3'23: €-35m)
- Net income of €+33m (Q3'23: €-31m)
- EPS of €+0.17 (Q3'23: €-0.16)
- FOCF of €112m (Q3'23: €308m)
- Total net debt (including pension provisions and net defined benefit asset) decreased from €3,193 on June 30, 2024 to €3,044m on September 30, 2024
- Net financial debt of €2,788m (€ 2,928m on June 30, 2024) / net pension liability (pension provisions and net defined benefit asset) of €256m (€265m on June 30, 2024)

- Sales increased by 4.1% Y/Y to €1,777m with volume +8.6%, price -3.6%, FX -0.9%
- EBITDA of €125m (Q3'23: €85m) driven by positive others and volumes while decreasing pricing delta

### **Solutions & Specialties**

- Sales decreased by 2.0% Y/Y to €1,773m with volume +3.9%, price -4.9%, FX -1.0%
- EBITDA of €208m (Q3'23: €246m) driven by negative pricing delta and others while increasing volumes

# **Others/Consolidation**

• EBITDA of €-46m (Q3'23: €-54m)

- FOCF between €-100 and €+100m; with Performance Materials FOCF and Solutions & Specialties FOCF each significantly<sup>3</sup> below previous year
- ROCE above WACC between -7pp and -5pp with WACC of 8.1%
- CO<sub>2</sub>E between 4.4MT and 5.0MT
